CONCENTRATE DISINFECTION PROTOCOL

ONE

Dilute PREempt[™] Concentrate 1:40 (one part PREempt[™] with 40 parts water or 25mL to 1L).

Read label or reference sheet for other dilutions.



TWO

Apply diluted solution to surface with sprayer. Diluted solution can be used for up to 30 days.

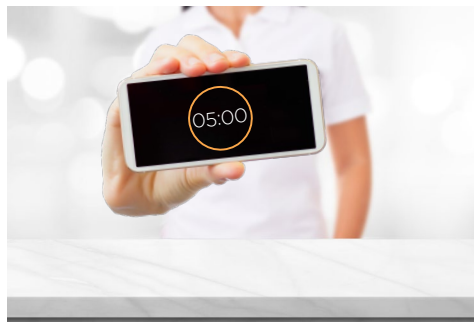
Personal Protective Equipment (PPE) not required at in-use dilutions.



THREE

Allow surface to remain wet for 5 minutes to kill viruses, bacteria and fungi per label instructions.

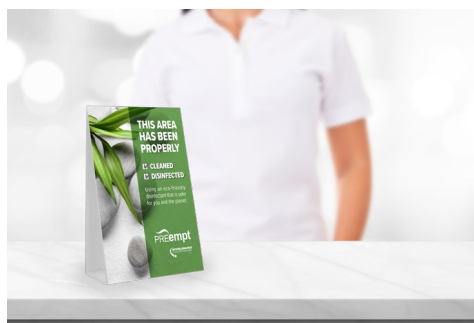
Read label or reference sheet for full list of claims.



FOUR

Leave to air dry.

Optionally wipe any excess solution using clean cloth after required contact time has been achieved.



BEST PRACTICES

■ Disinfection should take place **after each and every** client service or treatment to prevent the spread of germs and infection.

■ During any kind of an outbreak or seasonal flu, use a **checklist** and have salon/spa staff routinely disinfect those items throughout the day. Proper hand hygiene should be performed following cleaning and disinfection.

■ Bottles should not be topped up with fresh solution and the containers should be cleaned and dried prior to reusing.

DISINFECTION CHECKLIST

- Workstations
- Counters
- Basin footbaths (incl. magnetic jets)
- Piped/whirlpool footbaths
- Common area surfaces, racks, shelves
- Restroom surfaces
- Tables, chairs and all seating areas
- Employee lockers and lunchroom

*Follow the circulating footbath specific protocol for this equipment.
